4. WANEKA PRIVATE LIMITED JOINT VENTURE BETWEEN CITY OF HARARE AND INFRASTRUCTURE BANK OF ZIMBABWE (IDBZ) (4)

The Committee had before it a report (20th March 2024 circulated with the Agenda) by the Director of Housing and Community services recommending noting of the status report on Waneka Private Limited: Joint Venture between City of Harare and Infrastructural Development Bank (IDBZ).

The Chairperson of the Joint Committee who was also the Chairperson of the Audit Committee however enlightened the Committee that his Committee had made a resolution that consideration of all Joint Ventures for Housing including those individuals who had been allocated land which was more than one Hectare

for various Housing purposes be held in abeyance as the Audit Committee was investigating such allocations and Joint Ventures dating back from 2017 to date hence there was need to put the matter in abeyance until such investigations were finalized. The Committee further asserted that no individual should be allocated more than one (1) unit of cluster housing land and that allocation should be drawn from housing waiting list.

The Chairperson further explained that in terms of Section 98 of the Urban Council's Act, his Committee had the mandate to call anyone whom it needed information from and would be calling Directors and other Council Officials which it deemed critical to give information as part of the investigations.

The Committee concurred with the Chairperson's recommendation and following discussion, the Committee:
